1. INTRODUCTION TO SARAO

The South African Radio Astronomy Observatory (SARAO, formerly in part SKA SA) is the business unit of the National Research Foundation (NRF) that houses and operates South Africa's national radio telescope shared facilities, including the MeerKAT, KAT-7, and Hartbeeshoek 26-m radio telescopes.

As a member of the international effort to build the Square Kilometre Array (SKA), which will be the world's largest radio telescope, South Africa (through the NRF's business units) is responsible for the construction and operation of the MeerKAT precursor telescope, for hosting the SKA Mid Frequency telescope, and for implementation of the African VLBI Network.

The SARAO project office has offices based in Johannesburg and Cape Town, as well as the radio-quiet SKA host site in the Karoo, 90km from Carnarvon in the Northern Cape, which hosts the Square Kilometre Array mid-frequency telescopes, MeerKAT, and KAT-7 radio telescope installations, as well as a number of guest instruments, including the HERA telescope.

2. SCOPE OF WORK

The South African Radio Astronomy Observatory (SARAO) requires the services of a qualified and accredited service provider to undertake the inspection, servicing, maintenance, testing, and certification of gas suppression systems installed in three server rooms for a period of two (2) years.

The objective is to ensure that all gas suppression systems remain fully operational, compliant with applicable standards, and capable of protecting critical IT infrastructure in the event of a fire.

The appointed service provider shall provide the following services for three (3) server room gas suppression systems over a two-year period:

Inspection and Servicing

- Conduct scheduled inspections and preventative maintenance of all gas suppression system components.
- Inspect cylinders, discharge nozzles, pipework, control panels, detectors, alarms, manual release stations, and associated equipment.
- Verify correct operation of all detection, activation, and alarm functions.
- Test system interfaces with building management and fire alarm systems where applicable.
- Provide detailed service reports after each maintenance visit.

Integrity Testing

- Conduct room integrity (door fan) testing for each protected server room.
- Verify that each room is capable of maintaining the required extinguishing agent concentration for the prescribed hold time.
- Identify any leakage paths that may compromise system performance.
- Provide detailed integrity test reports and recommendations for remedial actions where deficiencies are identified.

Assessment of Damage and Corrosion

- Inspect all gas suppression system components for:
 - Physical damage;
 - Corrosion;
 - Wear and deterioration;
 - Gas leaks;
 - Mechanical defects;
 - Non-compliance with applicable standards.
- Submit a report detailing any defects identified and recommended corrective actions.

Removal and Disposal of Existing Cylinders

- Safely disconnect, remove, transport, and dispose of obsolete or expired gas suppression cylinders/bottles.
- Disposal shall be undertaken in accordance with all applicable environmental, health, and safety regulations.
- Provide disposal certificates or proof of lawful disposal where applicable.

Compliance Requirements

The service provider shall:

- Be suitably qualified and experienced in the maintenance of gaseous fire suppression systems.
- Comply with all applicable South African National Standards (SANS) and fire protection regulations.
- Ensure all technicians are trained and certified to work on the installed gas suppression systems.
- Use calibrated testing equipment and provide calibration certificates upon request.

Safety Requirements

Safety File

The successful bidder shall submit a comprehensive Safety File prior to commencing any work on site. The Safety File shall include, at a minimum:

- Company Health and Safety Policy;
- Risk Assessment and Method Statements;
- Letter of Good Standing with the Compensation Fund (COIDA);
- Proof of employee medical fitness where applicable;
- Proof of competency and training of personnel;
- Copies of identity documents of personnel attending site;
- Emergency procedures;
- Personal Protective Equipment (PPE) requirements;
- Any other documentation required by SARAO's Health and Safety requirements.

No work shall commence until the Safety File has been reviewed and accepted by SARAO

Deliverables

The service provider shall provide:

- Service and maintenance reports for each visit;
- Room integrity test reports for each server room;
- Defect and non-conformance reports;

- Recommendations for remedial actions where required;
- Disposal certificates for removed cylinders;
- Compliance certificates where applicable;
- Final summary report at the completion of the contract period.

Contract Period

The contract shall be valid for a period of twenty-four (24) months from the date of appointment.

Bidders shall provide pricing for:

- Routine servicing and maintenance of three server room gas suppression systems for two years;
- Room integrity testing for each server room;
- Inspection for damage, leaks, and corrosion;
- Removal and disposal of obsolete cylinders;
- Labour, travel, equipment, testing, and reporting;
- Any additional costs must be clearly indicated.

SARAO reserves the right to accept or reject any bid in part or in full and is not bound to select the lowest-priced bid.
